Gender, Justice, Empire: Contextual Readings of the Old Testament

Description

This course explores the relationship between issues of gender, justice and empire in Old Testament interpretation. Through a study of a number of Old Testament texts, particularly those, which narrate the experience of women within the wider social and imperial contexts, we will consider how these themes are configured and related within biblical traditions. The unit will introduce feminist/womanist, African, Asian, Dalit feminist and Latin American/Mujerista and Postcolonial feminist approaches to the study of the Bible and will engage in a close reading of a range of primary Old Testament texts from these varied perspectives. It will also examine how these diverse hermeneutical perspectives engage and critique traditional/classical exegetical approaches in their attention to issues of gender, justice and empire. The overall approach will be interdisciplinary and will provide students opportunity to study these texts alongside contemporary women's experiences and portrayals of women in other media such as art, film, poetry, and law.

Learning outcomes

Upon successful completion of this unit, it is expected that Level 2 students will be able to:

- 1. Demonstrate familiarity with the Old Testament narratives of Biblical women and knowledge of relevant issues of gender, justice and empire in relation to these texts and the Old Testament overall.
- 2. Recognize the liberational and the oppressive potential of biblical stories.
- 3. Discuss and appraise how these new and emerging approaches, namely feminist/womanist; African, Asian, Latino/Mujerista, postcolonial; liberation; and Dalit perspectives inform the interpretation of biblical texts.
- 4. Interpret Biblical texts with attention to the Australian Context

Upon successful completion of this unit, it is expected that Level 3 students will be able to:

- 1. Demonstrate in-depth familiarity with the Old Testament narratives of Biblical women and knowledge of relevant issues of gender, justice and empire in relation to these texts and the Old Testament overall.
- 2. Critically engage with how these new and emerging approaches, namely feminist/womanist; postcolonial; liberation; and Dalit perspectives inform the interpretation of biblical texts.
- Develop a comparative and global framework in the study of the Old Testament in order to will foster appreciation and respect for other/diverse perspectives
- 4. Interpret Biblical texts with attention to the Australian Context.

- 3. Engage critically with the feminist/liberational/postcolonial critique of traditional fields of knowledge, biblical methodology and hermeneutics and integrate these methodological perspectives into creative thinking and study of the Old Testament
- 4. Interpret Biblical texts with attention to the Australian Context
- 5. Develop a comparative and global framework in the study of the Old Testament and to foster appreciation and respect for other/diverse perspectives
